The JP Domain Name Dispute Resolution Policy (JP-DRP) has been established as an alternative dispute resolution procedure for disputes over JP domain names. On the 20th anniversary of the adoption of the JP-DRP, a symposium was held where all concerned parties in Japan gathered. We feature the symposium in Special Article 1. The symposium was divided into two parts: The first part introduced the revised JP-DRP, which came into effect on October 1, 2020, following the computerization of JP-DRP procedures, and provided an opportunity to deepen participants' understanding of how to further utilize said procedures. In the second part of the symposium, we introduced some of the most noteworthy cases from the JP-DRP Decision Examples Study Report, which summarized the cases reviewed in 2018-2019, and examined their current status and issues.

We chose this theme to highlight the spirit of finding exciting things we can do even if we have to give up some things because of the COVID-19 crisis. From the interview, we learned that she has been immersed in the Internet since she was a small child. She talks about her motivation and interest in the Internet industry.

In our "10 Minute Internet Course", we explore the System for Standardized Access Disclosure (SSAD) that has been discussed within the GNSO (Generic Names Supporting Organization) of ICANN (The Internet Corporation for Assigned Names and Numbers). In order to comply with the General Data Protection Regulation (GDPR), the WHOIS service (or Registration Directory Service (RDS)) provides a limited amount of information for common inquiries. SSAD is a mechanism for disclosing more information than is available to the public, only if it is found that inquiries have a legitimate purpose (criminal investigations, intellectual property disputes over domain names, cybersecurity investigations, etc.).
